*If hall is left clean as directed below \$50.00 fee will be refunded by check within 10 days of rental.

****RENTER WILL BE GIVEN 1 HOUR PRIOR TO FUNCTION START TIME TO SET UP AND ½ HOUR FROM END TIME TO BREAK DOWN, UNLESS PRIOR ARRANGEMENTS HAVE BEEN MADE AND APPROVED BY MANAGER.**

OUR FUNCTION HALL IS NO SMOKING/NO VAPING NO EXCEPTIONS.
Friday and Saturday night functions are a max time of 4 hours!

Function Room

1) 4 hours (min) - \$225.00 5 hours - \$275.00 6 hours (max) - \$300.00

2) **\$50.00 License Fee is non-refundable and in addition for hall rents with a bartender.**

3) Bartenders will be paid from ½ hour before the function begins until ½ hour after the functions ends at the rate of **\$10.00 per hour.**

******If renter is not finished with cleanup within that ½ hour time frame the renter will pay bartender until cleanup is finished at a rate of \$10.00 per half hour thereafter.**

3A) Parties with more than 85 guests will be determined by Manager as to if two bartenders will be required

4) If kitchen is required there will be a **\$75.00** fee. Pots, pans, utensils etc. are not furnished by the VFW and must be brought in by the renter as needed.

5) Renter agrees to pay a **\$50.00** upfront cleaning fee deposit, if the hall is left as it was given which means: kitchen is cleaned and swept, hall floor is swept, all decorations are removed, trash is removed, tables and chairs are washed and put away as found the cleaning deposit will be returned by check via mail within 10 days. If the hall is not cleaned as directed above the renter will forfeit \$50.00 cleaning deposit [REDACTED].

6) ****Renters without a bartender **MUST** come down to let the bartender know that they Have finished and are ready to leave so bartender can go up inspect and lock up, **FAILURE TO DO SO WILL RESULT IN FORFEITURE OF CLEANING DEPOSIT.**

***Under no circumstance can there be any decorations hung by tape, command strips or tacks on any walls/doors/ceilings or pipes. Decorations can only be placed on tables, renter understands they will forfeit their entire cleaning deposit if not compliant.

Renter understands no alcoholic beverages are to be provided to any individuals under the age of 21, nor any alcoholic beverages brought into function hall. Renter will ensure that no outside beverages, **with the exception of coffee and or juice boxes for small children**, are to be brought into the function hall when there is a bartender on duty [REDACTED] (initial)

When no bartender is present, **ONLY** water, soda, juice and coffee may be brought in.

If paying by check, balance is due 14 days prior to rental.

If paying within the 14 days prior to rental, only **cash** will be accepted.

Should renter cancel prior to 14 days of function a refund check will be mailed within 10 days to the renters address on license minus the \$50.00 license fee.
